The Three Rs:

• Students learn the importance of waste reduction and reuse and, that recycling isn't what we think it is.

Trash Audit:

Students identify and record the components of their waste stream and organize the data collected.

Where Stuff Comes From:

Students learn what natural resources are used to make the stuff of their everyday lives.

Vermicomposting:

 Students learn how vermicomposting can help with waste reduction goals while learning about red wiggler worms and worm bin ecosystems.

Paper Making:

• Students learn about paper recycling and its importance in waste reduction while making paper they can take home.

Global Climate Change:

• Students learn the current state of the science of global climate change as well as the political controversy.

Food Waste:

• Students learn about the costs associated with food waste.
