
The **entrance** to the OSLC clinic is located on the south side of the building.

About Adolescent & Family Services

Adolescent & Family Services specializes in providing a proven family-based treatment for adolescents (ages 12-18 years) struggling with substance use problems.

Counseling services are provided in an outpatient setting at one of our two Eugene locations.

Adolescent & Family Services provides an evidence-based treatment for youth addiction called Contingency Management (CM). CM includes cognitive behavioral and behavioral approaches with active parent involvement. Research has shown that CM is one of the most effective treatments for teen substance use.

Treatment Information

HOW DOES MY CHILD QUALIFY FOR TREATMENT AT THE CLINIC?

Treatment at Adolescent & Family Services is provided as part of a research study. The study requires parents and youth to participate in research surveys and research interviews. Parents and youth earn money for the research interviews. The money is for research interviews, not for time spent in treatment sessions. If parents or youth do not want to participate in research, Adolescent & Family Services can provide referrals to other local clinics for treatment.

WHAT WILL TREATMENT COST?

There are no out-of-pocket charges for treatment. The clinic will accept Oregon Health Plan (Trillium Health Plan) or will cover the cost of treatment with a grant from the National Institute on Drug Abuse. To receive treatment at Adolescent & Family Services, families must qualify and consent to participate in research.

HOW DO I SCHEDULE AN APPOINTMENT?

Appointments are scheduled based on counselor availability. Families wishing to see a counselor at the OSLC location should call (541) 284-7560 and ask for an appointment with Adolescent & Family Services. Spanish-speaking families wishing to see a counselor at the Centro location should call Maria Dominguez at (541) 687-2667 ext. 129.

THE BENEFITS OF TREATMENT

There are many benefits of treatment, including:

- Improved family relationships
- Improved peer relationships
- Improved school functioning
- Improved community functioning

It is important to note, however, that our program is not a "quick fix." Services are most effective when there is a high level of parent support and involvement in treatment and when adolescents are committed and cooperative.

WHAT TO EXPECT

Treatment sessions occur at least once a week. In general, each session lasts approximately 60 to 90 minutes, and every attempt is made to begin and end sessions on time. In addition to office sessions, therapists may schedule phone sessions as part of treatment. Treatment is individualized to each family's needs.

OUR CONFIDENTIALITY POLICY

As with all clinical services at OSLC and Centro, Adolescent & Family Services provides confidential treatment.
