Greetings Kinder Teachers and Title Coordinators,

We are seeking licensed teachers to work as a **KITS Site Supervisor** this summer. The skills and expertise gained from this experience is especially relevant for Kinder teachers or Title 1 Coordinators, and so I wanted to be sure you all knew about this opportunity. The KITS program (Kids In Transition to School) is for children entering kindergarten. This position offers paid training and embedded coaching from Oregon Social Learning Center. The Site Supervisor would be overseeing 1 am and 1 pm KITS class at their site. KITS runs three days a week on Tues/Wed/Thurs for 8 weeks over the summer. KITS Site Supervisor is **posted now and will remain open until April 17th**.

We are also seeking staff to fill the **KITS Lead Educator** positions. This would be a great fit for a kinder EA or for Title staff who want to lead lessons as part of a trained and supported team. Training and curriculum provided.

Finally we have also reposted for the **KITS Parent Group Facilitator**. This is also open to classified or certified staff who are interested in connecting families through a weekly parent lesson. Training and curriculum provided. This position would be a much lighter time commitment for folks interested in KITS but wanting to keep their schedules mostly open.
