It's time to start planning for OSAS this spring. Please reach out to your administrators to begin planning your school's testing schedule and enter the dates on the following spreadsheets: [Elementary](#), [Middle/High School](#), [Charters/Alternative Programs](#). The sooner we can know your specific schedule, the more time we have to support the preparation of technology (devices, secure browsers, accommodations, etc). Testing windows and other scheduling guidelines are within each google sheet.

High Schools: Please note that the 11th grade ELA/Math/Science test window starts on **February 6**. This is the second day of the second semester. If 11th grade students don't have a math, science, or ELA course scheduled in their second semester, other arrangements will need to be made so that those students can have an opportunity test. Wednesday schedules may be a useful time for these (if not all) 11th grade students.

Elementary and Middle Schools: Please note that the Science window opens earlier (March 5) than ELA/Math (April 2).

Please plan to attend **one** of the following STC training sessions so that you can move forward with your site's Spring 2023 OSAS summative tests. Below are dates/times for six options in the next six weeks. I'll offer more trainings later in February/early March.
