## What Does the Executive Branch Do?

- Legislative Branch- Makes laws
- Executive Branch <u>Carries out & enforces</u> laws passed by Congress.
  - The <u>President is head of the US government's</u> <u>executive branch</u>.
  - The U.S. is a presidential democracy; our <u>executive and legislative branches are</u> <u>SEPARATE</u>.
- Judicial Branch- Interprets the laws and acts of government. Are they constitutional?

## What are the key roles in the Executive Branch?

- **1. The President** <u>Leads the country;</u> is <u>head</u> of state, leader of the government and commander-in-chief of armed forces.
- 2. Vice President <u>Supports the P</u>. <u>Succeeds</u> <u>the P</u> if s/he is unable to serve.
- 3. **Cabinet** <u>Advise the P</u> and <u>lead</u> <u>departments of the executive branch</u>. Are <u>nominated by P and approved by Senate</u>.
- 4. Federal Bureaucracy- Millions of citizens who are employed by the federal gov't to carry out the work of enforcing laws.

# The President of the U.S. (POTUS)

- There have been <u>45</u>
  <u>Presidents</u>
- Highly educated
- <u>Elite</u>
- All <u>men</u> (so far)
- Obama was first non-white P
- **Trump** is first with no previous formal political experience.



#### Why is the P's Job so Difficult?

- Inherent <u>stress in leading one of the most</u> powerful nations in the world today
- P is the single most identifiable member of government- is blamed for problems
- The job is difficult- <u>crises/emergencies</u> <u>happen</u>
- It isn't easy to please people!

## What are the roles of the President Today?

- The <u>US President has many job</u> responsibilities that require different skills. This is one of the significant reasons the job is so difficult.
- P must be a good <u>LEADER</u> (of people, the country and the military), <u>MANAGER</u>, <u>VISIONARY</u>, <u>DIPLOMAT</u>, <u>MODEL</u>
  <u>CITIZEN</u>

#### What are the Constitutional Qualifications for US President?

There are only THREE written requirements-

- 1. Must be "a natural born citizen" of the U.S.
- 2. Must be <u>at least 35 years old</u>
- 3. Must have lived in the U.S. for 14 years.

\*There are **informal qualifications**, too. -Highly educated, wealthy, national political experience, male(?)

### How Long is the Term?

- Each Presidential term is 4 years long.
- What is the <u>22<sup>nd</sup> Amendment</u> (1951) It set a presidential term limit at TWO terms maximum or 10 years (if a VP succeeds to the presidency).
- FDR had violated the custom of two terms by running and winning FOUR terms. He died during his fourth.



### Pay / Benefits

- Congress sets the President's pay
- Salary is \$400,000/year (as of 2001)
- Plus a <u>\$50,000 expense account</u>
- <u>\$100,000 non taxable travel account</u>
- <u>\$19,000 entertainment account</u>

### What is the role of the VP?

- The <u>VP's most important role is to take</u> over if the President is unable to serve.
- The <u>VP also serves as the President of the</u>
  <u>Senate</u>
- The <u>VP has other ceremonial duties and</u> <u>assists the President</u>.

### Presidential Succession (13.2)

- What is Succession?: The plan to fill the vacancy of the office of the President should he leave office through death, resignation or impeachment.
- Had been customary to have VP take over but wasn't official

## Presidential Succession Act of 1947

- Law passed by Congress, it <u>sets up order</u> of succession if President dies, resigns or becomes disabled...
- **1. Vice President**
- 2. Speaker of the House
- 3. President pro tempore of the Senate
- 4. Secretary of State

### Presidential Succession Act of 1947

- 5. Secretary of the Treasury
- 6. Secretary of Defense
- 7. Attorney General
- 8. Secretary of the Interior
- 9. Secretary of Agriculture
- 10. Secretary of Commerce
- 11. Secretary of Labor...

### What if the President is sick?

#### Examples:

- Eisenhower: suffered heart attack in 1955, ileitis in 1956, and mild stroke in 1955
- James Garfield: lingered for 80 days before he died of an assassin's bullet in 1881
- Woodrow Wilson suffered a stoke in 1919 and was unable to run for his second term
- Ronald Reagan was gravely wounded in an assassination attempt in 1981

## What is the 25<sup>th</sup> Amendment (1967)?

- Outlines what happens in case President becomes disabled while in office.
- Under the 25<sup>th</sup> Amendment, <u>the VP</u> <u>becomes acting President if</u>
- President tells Congress he can't do his job, or
- VP and a majority of the cabinet tell Congress that the President can't do his job.

#### **Vice President**

#### VP has just two duties in original Constitution:

- To serve as President of the Senate
- To help decide if President is disabled
- Most importantly, as of 25<sup>th</sup> Amendment, he can <u>succeed to the Presidency</u> due to death or resignation of the P.

## Why is job of VP so lightly regarded?

- Very few stated duties in the Constitution.
- Political parties often pick VP candidates to "balance the ticket" and win the election; not necessarily for their abilities.
- VP's role is thought of as symbolic

#### Vice Presidents Who Succeeded to the Presidency

Successor	Reason for Succession
John Tyler	Death (pneumonia) of William Henry Harrison, April 4, 1841
Millard Fillmore	Death (gastroenteritis) of Zachary Taylor, July 9, 1850
Andrew Johnson	Death (assassination) of Abraham Lincoln, April 15, 1865
Chester A. Arthur	Death (assassination) of James A. Garfield, September 19, 1881
Theodore Roosevelt	Death (assassination) of William McKinley, September 14, 1901
Calvin Coolidge	Death (undisclosed illness) of Warren G. Harding, August 2, 1923
Harry S Truman	Death (cerebral hemorrhage) of Franklin D. Roosevelt, April 12, 1945
Lyndon B. Johnson	Death (assassination) of John F. Kennedy, November 22, 1963
Gerald R. Ford	Resignation of Richard M. Nixon, August 9, 1974
